Subject: Verizon Partner Solutions Industry Letter: Ronkonkoma NY 5E Switch Retirement

PLEASE NOTE:

- All references to the Ronkonkoma NY 5E switch are associated with CLLI code RNKNNYRNDS0 and will not be repeated throughout this letter.
- •All references to the Deerpark NY CS2k switch are associated with CLLI code DRPKNYDPPS0 and will not be repeated throughout this letter.

As set out in the Verizon New York Inc. Public Notice of Network Change Under Rule 51.329(a), dated January 14, 2025, on or after July 2, 2025, the Ronkonkoma NY 5E switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 631 currently residing in the Ronkonkoma NY 5E switch (see list in Table B below) will be moved to the Deerpark NY CS2k switch (see details in Table A below).

The native NPA NXXs belonging to the Ronkonkoma NY 5E switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Deerpark NY CS2k switch. This will occur on or after July 2, 2025.

Network Changes and Trunk Rearrangements:

The Deerpark NY CS2k switch will be the recipient office of traffic migrated from the Ronkonkoma NY 5E switch. Traffic bound for the codes listed in Table B will be delivered via the BRWDNTBWGT0 Brentwood / DPG0T Tandem (DRPKNYDPG0Tintra-lata SHA / DRPKNYDPG0T inter-lata FG Access SHA).

After all traffic is migrated off the Ronkonkoma NY 5E switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Deerpark NY CS2k switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Ronkonkoma NY 5E switch will be required to reposition the codes to the Deerpark NY CS2k switch

All ASRs for the Deerpark NY CS2k switch must be received no later than May 1, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by July 2, 2025 per LERG.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Ronkonkoma NY 5E switch.
