## Subject : Verizon Partner Solutions Industry Letter: Marshallton DE DMS100 Switch Retirement

### PLEASE NOTE:

- All references to the Marshallton DE DMS100 switch are associated with CLLI code MSTNDEMADS0 and will not be repeated throughout this letter.
- All references to the Wilmington DE CS2K switch are associated with CLLI code WLMGDEWLPS1 and will not be repeated throughout this letter.

As set out in the Verizon Delaware LLC Public Notice of Network Change Under Rule 51.329(a), dated January 14, 2025, on or after July 2, 2025, the Marshallton DE DMS100 switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

**General Information:** The Exchange Codes (NXXs) in Numbering Plan Area (NPA) 302 currently residing in the Marshallton DE DMS100 switch (see list in Table B below) will be moved to the Wilmington DE CS2K switch (see details in Table A below).

The twelve (12) native NPA NXXs belonging to the Marshallton DE DMS100 switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Wilmington DE CS2K switch. This will occur on or after July 2, 2025.

### Network Changes and Trunk Rearrangements:

The Wilmington DE CS2K switch will be the recipient office of traffic migrated from the Marshallton DE DMS100 switch. Traffic bound for the codes listed in Table B will be delivered via the Wilmington 72T Tandem (WLMGDEWL72T).

After all traffic is migrated off the Marshallton DE DMS100 switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers, and paging carriers will need to secure new trunk groups built to the Wilmington DE CS2K switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Marshallton DE DMS100 switch will be required to reposition the codes to the Wilmington DE CS2K switch.

All ASRs for the Wilmington DE CS2K switch must be received no later than June 2, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by July 2, 2025.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Marshallton DE DMS100 switch.
