## Subject : Verizon Partner Solutions Industry Letter: Syracuse NY and Utica NY Oracle Signal Transfer Point (STP) Switch Retirements

## **PLEASE NOTE:**

- All references to the Syracuse NY Oracle STP switch are associated with CLLI code **SYRCNYSU04W** and will not be repeated throughout this letter.
- •All references to the Garden City NY Oracle EAGLE STP switch are associated with CLLI code **GRCYNYGC85W** and will not be repeated throughout this letter.
- •All references to the Utica NY Oracle STP switch are associated with CLLI code **UTICNYUT04W** and will not be repeated throughout this letter.
- •All references to the White Plains NY Oracle EAGLE STP switch are associated with CLLI code **WHPLNYWP09W** and will not be repeated throughout this letter.

As set out in the March 7, 2025, Verizon New York Inc. Public Notice of Network Change Under Rule 51.329(a), on or after September 15, 2025, the Verizon Syracuse NY Oracle STP switch, located at 210 South State Street, Syracuse, NY 13202, will be retired and removed from the Verizon network after all the Signaling System 7 (SS7) links are rehomed to the Verizon Garden City NY Oracle EAGLE STP switch, located at 741 Zeckendorf Boulevard, Garden City, NY 11530. Also, the Verizon Utica NY Oracle STP switch, located at 280 Genesee Street, Utica, NY 13502, will be retired and removed from the Verizon network after all the SS7 links are rehomed to the Verizon White Plains NY Oracle EAGLE STP switch, located at 111 Main Street. White Plains. NY 10601.

**General Information:** Verizon will make changes to its SS7 network and services. The Syracuse NY and Utica NY Oracle STP switches will be removed from service and the SS7 traffic will be moved to the Garden City NY and the White Plains NY Oracle EAGLE STP switches, respectively. ## **Network Changes:**

The Garden City NY Oracle EAGLE STP switch will be the recipient of the SS7 traffic rehomed off of the Syracuse NY Oracle STP switch and the White Plains NY Oracle EAGLE STP switch will be the recipient of the SS7 traffic rehomed off of the Litica NY Oracle STP switch

SS7 Service providers with SS7 link terminations in Verizons Syracuse NY and Utica NY Oracle STP switches will be contacted prior to the rehome to confirm new route sets to the Garden City NY and the White Plains NY Oracle EAGLE STP switches. Due to Multi Point Code features in these STP, the older Point code continues to exist in the Garden City NY and White Plains NY Oracle EAGLE STP switches. All necessary changes will be completed by Verizon.

SS7 service providers and any other affected carriers may need to alter their SS7 transport, OffNet services arrangements

(services obtained from third parties) and/or Gateway services in order to access or continue serving customers served by offices currently homed to the Syracuse NY and Utica NY Oracle STP switches.

After all traffic is migrated off the Syracuse NY and Utica NY Oracle STP switches, all network elements associated with these STP switches will be removed from service and the equipment will be decommissioned and removed on or after September 15, 2025.
