Subject : Verizon Partner Solutions Industry Letter: Rochelle Park NJ CS2K Switch Retirement

This Notice amends Verizon New Jersey Inc.s September 1, 2022, Industry Letter with a switch retirement implementation date of on or after March 20, 2023. With this amendment, Verizon New Jersey Inc. extends the implementation date to on or after December 1, 2026.

PLEASE NOTE:

- All references to the Rochelle Park NJ CS2K switch are associated with CLLI code RCPKNJ01PS0 and will not be repeated throughout this letter.
- All references to the New Brunswick NJ C20 switch are associated with CLLI code NBWKNJNBPS2 and will not be repeated throughout this letter.

As set out in the Verizon New Jersey Inc. Public Notice of Network Change Under Rule 51.329(a), dated March 24, 2025, on or after December 1, 2026, the Rochelle Park NJ CS2K switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPA) 201 subtending to the eleven (11) end offices (see Table B below) will be moved to the New Brunswick NJ C20 switch (see details in Table A below). Traffic bound for remote offices homed off of the Rochelle Park NJ CS2K will be accommodated by the New Brunswick NJ C20 subsequent to the December 1, 2026 date.

The NPA NXXs belonging to the Rochelle Park NJ CS2K switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the New Brunswick NJ C20 switch. This will occur on or after December 1, 2026.

Network Changes and Trunk Rearrangements:

The New Brunswick NJ C20 switch will be the recipient office of traffic migrated from the Rochelle Park NJ CS2K switch. Traffic bound for the codes listed in Table B will be delivered via the New Brunswick Tandems (NBWKNJNB04T intra-lata SHA &NBWKNJNB05T inter-lata SHA).

After all traffic is migrated off of the Rochelle Park NJ CS2K switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the New Brunswick NJ C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Rochelle Park NJ CS2K switch will be required to reposition the codes to the New Brunswick NJ C20 switch.

All ASRs for the New Brunswick NJ C20 switch must be received no later than October 15, 2026, to provide sufficient time to migrate the traffic described above. All traffic must be moved by December 1, 2026.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Rochelle Park NJ CS2K switch.
