Subject : Verizon Partner Solutions Industry Letter: Fairfax VA CS2K Switch Retirement

PLEASE NOTE:

- All references to the Fairfax VA CS2K switch are associated with CLLI code FRFXVAFFPS0 and will not be repeated throughout this letter.
- All references to the Fairfax VA C20 switch are associated with CLLI code FRFXVAFFPS1 and will not be repeated throughout this letter.

As set out in the Verizon Virginia LLC Short Term Public Notice Under Rule 51.333(a), dated June 27, 2025, on or after October 25, 2025, the Verizon Fairfax VA CS2K switch will be retired and removed from the Verizon network as part of ongoing efforts to modernize the network.

General Information: The Exchange Codes (NXXs) in Numbering Plan Areas (NPAs) 571 and 703 subtending to the eight (8) end offices (see Table B below) will be moved to the Fairfax VA C20 switch (see details in Table A below). Traffic bound for remote offices homed off of the Fairfax VA CS2K switch will be accommodated by the Fairfax VA C20 switch subsequent to October 25, 2025.

The NPA NXXs belonging to the Fairfax VA CS2K switch will be rehomed upon decommissioning of the switch and reflected in the Local Exchange Routing Guide (LERG) for the Fairfax VA C20 switch. This will occur on or after October 25, 2025.

Network Changes and Trunk Rearrangements:

The Fairfax VA C20 switch will be the recipient office of traffic migrated from the Fairfax VA CS2K switch. Traffic bound for the codes listed in Table B will be delivered via the Arlington and Southwest (WASHDCSWGOT intra-lata SHA & ARTNVAAR00T inter-lata SHA).

After all traffic is migrated off of the Fairfax VA CS2K switch, this switch will be retired and removed from the network.

CLECs, IXCs, IECs, wireless carriers and paging carriers will need to secure new trunk groups built to the Fairfax VA C20 switch or have existing trunk groups to that switch augmented. Carriers that have direct end office trunk (DEOT) with access connectivity in the Fairfax VA CS2K switch will be required to reposition the codes to the Fairfax VA C20 switch.

All ASRs for the Fairfax VA C20 switch must be received no later than September 1, 2025, to provide sufficient time to migrate the traffic described above. All traffic must be moved by October 25, 2025.

Please adhere to industry standards using normal procedures that pertain to updates and changes to the LERG for all NXXs subject to the retirement of the Fairfax VA CS2K switch.
