PLEASE NOTE:

- All references to the Poplar PA 5ESS switch are associated with CLLI code **PHLAPAPODS0** and will not be repeated throughout the notice.
- All references to the Market PA C20 switch are associated with CLLI code **PHLAPAMKPS2** and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Poplar PA 5ESS switch, located at 1601 W. Jefferson Street, Philadelphia, PA 19121, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Verizon Market PA C20 switch, located at 900 Race Street, Philadelphia, PA 19108. All traffic to be migrated to the Market PA C20 switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

Competitive local exchange carriers (CLECs), interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers will need to secure new trunk groups built to the Market PA C20 switch or have existing trunk groups to that switch augmented. Carriers that are code holders for access connectivity in the Poplar PA 5ESS switch will be required to reposition the codes to the Market PA C20 switch.

All ASRs for the Market PA C20 switch must be received no later than January 25, 2026, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Poplar PA 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Poplar PA 5ESS switch (**on or after March 26, 2026**). This will serve to guide interconnect re-routes of traffic for the eleven (11) native codes currently served by the Poplar PA 5ESS switch to reflect the

Market PA C20 switch as the new home switch.
