PLEASE NOTE:

- All references to the Chillum MD 5ESS switch are associated with CLI code HYVLMDCMDS0 and will not be repeated throughout the notice.
- All references to the Hyattsville MD CS2K switch are associated with CLI code HYVLMDHYPS0 and will not be repeated throughout the notice.

Description of the Planned Network Change(s):

The Verizon Chillum MD 5ESS switch, located at 6510 Riggs Road, Hyattsville, MD 20783, will be retired and removed from the Verizon network after all traffic served by this switch is migrated to the Verizon Hyattsville MD CS2K switch, located at 5500 Baltimore Avenue, Hyattsville, MD 20781. All traffic to be migrated to the Hyattsville MD CS2K switch includes, but is not limited to, Inter-LATA (ACCESS/FG-B-D/CLEC IXC), wireless and paging traffic.

Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):

All carriers—including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers—will need to provision new trunk groups to support direct end office trunking to the Hyattsville MD CS2K switch or have existing trunk groups to that switch augmented.

All ASRs for the Hyattsville MD CS2K switch must be received no later than **April 11, 2026**, to provide sufficient time to migrate the traffic described above. These direct end office trunk (DEOT) interconnections will support traffic migration for the Chillum MD 5ESS switch prior to its eventual decommissioning. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Chillum MD 5ESS switch (**on or after April 30, 2026**). This will serve to guide interconnect re-routes of traffic for the four (4) native codes currently served by the Chillum MD 5ESS switch to reflect the Hyattsville MD CS2K as the new home switch. All trunks to the Hyattsville MD CS2K switch must be in place prior to the decommissioning of the Chillum MD 5ESS switch.
